Please send me the project applications/descriptions, including the dollar amounts awarded, for the following LRP projects listed on the web page:

2019 - Partnered with a rancher in GMU 22 to convert an existing well to solar, add a new drinker location, and increase storage to provide a more reliable water source for deer.

2019 - Partnered with a rancher in GMU 24A to install 2 miles of new pipeline, additional storage, and an additional drinker to an existing well.

2019 - Partnered with a rancher in GMU 23 to add 1.25 miles of new pipeline, additional storage, and additional drinkers to an existing well.

2019 - Partnered with a rancher in GMU 23 to install 3.5 miles of new pipeline, additional storage, and 3 new drinkers to an existing well.

2018 - Partnered with a rancher in GMU 24A to clean and repair 13 existing dirt tanks to provide more reliable water for deer and small game.

2018 - Partnering with the Forest Service in GMU 35A to restore over 3,000 acres of grassland habitat to benefit a variety of big game and small game species.

2017 - Partnered with a rancher in GMU 23 to covert an existing well to solar providing reliable year-round water for mule deer and small game.

2017 - Partnered with a rancher and the Forest Service in GMU 35A to redrill an existing well to provide reliable year-round water for mule deer

Furthermore, the minutes from the January 12, 2019, meeting of the Landowner-Lessee/Sportsman Relations Committee (LLSRC) mention a \$30,000 LRP grant for the 51 Ranch in Game Unit 21 to build new livestock waters with the help of the AZ Mule Deer Organization.
